2015-02-02 <u>Water west of Trinity River:</u> The City of Baytown has seen our water rate schedules and they have a concern about the reservation fee. They are still willing to front the money to buy into the CWA system. We are still trying to obtain what the buy in amount will be. We will try to set up a meeting within the next two weeks with CWA and the City of Houston.

2015-02-03 <u>Budget hearing:</u> A budget hearing was called at 10:15 am. No comments were made on the budget hearing so it was closed at 10:17 am. After discussion with Baytown representatives, we resumed our budget workshop at 10:30 am. At closing the workshop meeting at 10:35 am, the regular board meeting was resumed at 10:36 am.

2015-02-07 <u>CDBG pump station project:</u> This project went out for bids and the low bid was \$600,000 more than the funds we have available. A meeting will be held with the GLO, County and Engineers on February 18th to discuss the next steps.

2015-02-08 <u>Dredging projects:</u> The Corps of Engineers wants to know if the concerns we have with condemnation of PA 7, is because it's outside our jurisdiction or just because we don't want to do condemnation. We need to contact our attorneys to see if we have jurisdiction to condemn property outside of our boundaries.

We need to set up a meeting with the Corps of Engineers the first of April to see about finding an alternate spoil disposal site.
