2016-01-01 Swearing in Board members: First on the agenda was the swearing in of board members by Liberty County Judge Jay Knight.

2016-01-02 Organization of Board: Motion was made by Wilcox, seconded by Mitchell and unanimously passed to appoint Terry Haltom as Chair. Passed Motion was made by Wilcox, seconded by Mitchell and unanimously passed to appoint Ken Coleman as Vice-Chairman. Passed Motion was made by Mitchell, seconded by Sterling and unanimously passed to appoint Dave Wilcox as Secretary. Passed

2016-01-03 Minutes: Motion was made by Wilcox, seconded by Coleman and unanimously passed to approve the minutes of December 15, 2015. Passed Mr. Sterling abstained from voting.

2016-01-05 <u>2016-2017 Budget Workshop and Hearing:</u> The 2016-2017 budget workshop will be held at 9:00 am on Tuesday February 16th, 2016. The Budget hearing will be held at 10:00 am.
2016-01-06 East side of Lake Anahuac project: The District has had a request from a landowner asking the District to put up a fence on his property so no unauthorized vehicle will be able to run on the levee. There are no funds available for the District to install a fence on his property. According to the engineer, the project is 60% complete and 85% complete at elevation 5 feet. Due to this project TBCD has turbidity issues with the water so they had to stop pumping and we agreed to adjust their billing next month if they have to pump over their minimum.
2016-01-08 <u>Executive Session</u> : The Board went into executive session at 9:17 am for discussion with attorneys. Regular session was reconvened at 9:31 am.
2016-01-09 Water Development Board-grant: Motion was made by Mitchell, seconded by Coleman and unanimously passed authorizing the resolution to the Water Development Board to go with the grant application for a metering system to be used in the canal. Passed
2016-01-10 <u>Dredging projects:</u> The Corps has had changes in its personnel so we are in the process of finding out who our new point of contacts are for all of our projects.
